Business Guide customs declaration for textile exports to the U.S. market

Implementing Document No. 6450/TCHQ-CNTT 15/11/2007 s General Administration of Customs , Binh Duong Customs Department customs declaration guide for textile exports to the U.S. market as follows :

1 - The declaration on the declaration criteria :

- In addition to the full report criteria (cells) on the customs declaration under the current regulations , the enterprise should declare all 05 criteria including : manufacturer code (MID code) , code U.S. HTS , Cat number , unit price FOB and product unit . The declaration on the declaration be made as follows :

- Box No. 1 export : Code additional declaration manufacturer (code MID) as 1059/TM-DM date 25/11/2005 Announcement of the Ministry of Commerce of the registration number of textile manufacturers garment exports to the United States ;

Commodity - Box No. 13, Specification : declare the structure consists of three parts, the middle part is the semicolon (;) as follows : the first section consists of HTS Code 10 of the United States, the second Catalog Number and including the third part consists Commodity specifications qualities. Corresponding HTS code list for each Cat can look at <u>http://www.customs.gov.vn</u>

For example : 6204624020 ; 348 , Capri pants or 6,204,423,060 ; 336 , long dresses for kids .

- Box Unit 16 : opening as assistant for all categories (except swimwear have some Cat 359/659 kg is open).

2 - Customs declaration on a computer system :

- The Cat has requested unit nurse manager is : declare on the customs declaration in question 16 Unit Unit is declared in accordance with the norms of the registration process or contract manufacture export ;

- The Cat has Unit , under the management requirements kg :

+ In Car Unit No. 16, with each item, to declare two types of business units: Unit declared to be the norm in the registration process or contract manufacturing exports (for example : the , the , the , ...); Monday Unit is declared kg;

+ In box 15 and box 17 Quantity Unit price shall declare the amount of currency units and corresponding unit price for each currency unit ;

+ For the line unit is kg , the Unit information , quantity , unit price currency must be placed in

parentheses .
