

2. Type of import export production

A. Export investors Production and export

Procedures for registration of export product categories (management applied by computer) ; registration , adjusted norms ; inspection at :

1 - Location and registration norms adjusted norms Registered : Department of Customs procedures imported materials .

2 - Time of registration norms and adjusted norms Registered : procedures before exporting .

3 - Work done :

a. To receive the table of the registered enterprises or adjust the level registered (08/DMNLNK/2006 sample) : 01 PLU 02 copies .

- Signed , sealed , and issued some public employees receive up to 02 copies ;

- Pay for 01 businesses to present to the customs authorities of export products (to check if the actual goods) ; Customs save the remaining track .

- For Customs Department information technology applications to manage more types NSXXK perform the following tasks :

+ Next to register the product portfolio exports (sample 07/DKSPXK/2006) : Civil servants to receive product portfolio check names , codes , unit , signature and seal of office on 02 statements by the enterprise portfolio , delivered 01 business , 01 kept at the customs office .

+ Import computer list of export products .

+ Enter on the machine .

b . Check the level in case of a suspected or business registration not properly adjusted to the actual norms .

Methods of test norms for such type of test performed NSXXK norm for this kind of processing .

Customs procedures for export product :

1 - The customs procedures for exports to foreign countries shall comply with the export trade of the General Department of Customs and add the following :

a - As a reality check goods inspectors have collated material form (obtained when imported by enterprises preserve and present) with materials constituting the actual product exports ; comparison actual exports against the norm of raw materials registered by the enterprise .

When questioned on the materials constituting improper export products to import raw materials or export products is not consistent with the norms of due process , the enterprise product sampling , making the records sealed specimen in accordance with regulations to be submitted to the Department for direction .

b - In case of units of Customs procedures for export products is not as units of Customs procedures for importing the raw materials prior to filing the export declaration registration :

- Department of Customs procedures where imported materials on writing a comment for Registration Department of Customs procedures for export of products NSXXK businesses by Form / DK XKSP/2006 accompanying this transition process Department Customs procedures for export products ; pay for 01 enterprises included in the dossier submitted to the Department of Customs gate to export procedures , saving the remaining 01 to follow up ;

- Department of Customs procedures gate of export products for businesses .

c - For the Customs Department information technology applications to manage NSXXK form to make more of the following :

c.1- duty Customs export declaration registration :

- Enter computer data of customs declarations according to the criteria on the computer or projector for business data transmission to the customs declaration .

c.2- date of the implementation of :

- For free shipment inspection of goods: Customs officials certifying the actual machine import export before the date of the actual export .

- For shipments to the actual inspection of goods , as a result of actual goods inspection , inspectors will type the actual details of export goods , customs officers certifying the actual machine entry export before the date of the actual export .

2 - In case of products exported in the form of import and export in place :

Follow the customs procedures for import and export goods in place by the General Administration of Customs issued .

- KL : same business process , but previous to declare business name imports raw materials to produce goods to export then consumption norms for export product then brought to registration records HQ

(applicable to export goods abroad)

- Registration materials for NK

- Registration norms

- TK export registration (threading , order forms)

- Inspect the goods

B. Enter Production and import investment

1 - This procedure specifies the work to be done to management for imported raw materials for the production of export goods (hereinafter referred to as the NSXXK form) along with the implementation of customs procedures for exports and import trade by General Administration of Customs issued and other regulations on customs procedures , tax policy , tax refund procedures for this type of guidance in Circular No.112/2005/TT-BTC dated 15/12/2005 , Circular 113 / 2005/TT-BTC dated 15/12/2005 of the Ministry of Finance and other relevant documents . So , when the customs procedures for this kind NSXXK customs officials to combine this process with the text above .

2 - To make a contract export products manufactured from imported raw materials by type NSXXK customs procedures performed in the following order :

- Sign contracts for import of raw materials , materials list ;
- Import of raw materials ; registration norms ;
- Export of products ;
- The balance sheet , tax refund , tax collection, (hereinafter referred to as liquidity) imported materials .

Registration and liquidity norms , depending on the amount and declaration of individual human Customs Department to organize the layout accordingly . The declaration is home to the largest of this type can be held responsible part for registration , inspection norms ; liquidity . The liquidity profile test can be done before or after reimbursement decisions , not taxes . Based on the actual situation , the credibility of the business, the directors of the provincial , city steering applied uniformly throughout the Department classifies enterprises to carry out inspection forms liquidity profile before or after reimbursement decisions , not tax revenue for each business .

3 - For exports , imports NSXXK form if transfer gate (including cases of registration of the declaration at a Customs Department but goods by other Customs Department reality check) then manually continuous transfer gate comply with the transfer gate .

4 - This procedures used to manage liquidity in the system NSXXK types of applications of information technology , both used to manage liquidity will be performed by manual methods . However , for the Customs Department has installed systems application of information technology to manage NSXXK form of the General Administration of Customs , the management and liquidation of imported raw materials for the production of necessarily export system applications using information technology , the Customs Department has not installed this system , the management , liquidity will be performed by manual methods .

Customs procedures for imports of raw materials :

Customs procedures for import of raw material in this process shall comply with the import of goods trade of the General Department of Customs and some of the following:

1 - Sign the contract and list of imported materials :

a. Contract imported raw materials for the production of export goods (hereinafter referred to as contracts) , the list of materials directly imported to produce goods for export registration procedures

when importing shipments the first contract : 02 copies of the list of materials ; 01 original and 01 copies of the import contract .

b. The list of materials by enterprises to have full registration criteria :

- Name ; materials HS ; material code (defined by the enterprise under the guidance of the Department of Customs procedures imported raw materials) ;
- Unit on the list of statistical units Vietnam ;
- Main materials defined by the enterprise . The main material is the basic raw material for the production of products or raw materials to produce these parts , basic details of the product (for example, items of clothing for the body fabric to make clothes , collar , sleeves , shirt, body clothing is the main raw material) ;

The above criteria must be uniform throughout the process from being imported to the liquidation .

c. The officer who received the contract, a list of materials , signed and sealed contract and civil servants on the list , assigned a 01 enterprises , customs authorities saved the original list of 01 materials , 01 import copy of the contract to monitor and compare the procedures Lie imported materials

2 - Sampling main materials :

a- In the case of actual inspection of goods: Customs officials shall take the form of actual goods inspection . Sampling was carried out in the following order :

- Prepare votes sampling 10/PLM/2006 enclosed form ;
- Sampling main materials . For the main material is gold , precious stones and the goods can not be long-term preservation (eg, skin alive ...) are not sampled .
- Customs officials and representative sampling shall sign on the sampling card ;
- Customs seals attached voucher specimen sampling , storage allocation for businesses to present to the customs authorities upon request .
- List the name of the material sampled on the customs declaration ;

b - For -free reality check :

If the procedure b.1 import raw materials at border gate customs sub-department entry : the material sampled by the Department of Customs entry gate implementation .

If b.2 - import procedures materials do not register at the gate Customs Sub-Departments enter :

- Customs officials of the Department of Customs procedures imported materials shall take the form signed and stamped by the Customs Department officials to send proposals sampling gate . In stock sampling specify the materials to be sampled at the same time record box 37 (other records of customs) of customs declarations content to sample the goods , and sign and seal of office.
- Customs Department carried out the sampling gate material prior to release . Customs officials sampled by sub-department leadership . The order of a point sampled as described above, except shares sample set .

- In case the proposal is now in the warehouse of sampled enterprises (which is recognized as the test location) or check the venue s focus Customs import procedures , the Customs Department clearance import the record into the box 37 of the customs declaration Suggest content customs seal gate of storage media , signed and sealed by civil servants sealed gate customs , customs seal numbers recorded on import declarations , customs import procedures where elected officials to warehouse or place of business focus to test samples of materials .

3 - For the Customs Department information technology applications to manage Production and import form, in addition to the provisions referred to in point 1 , point 2 , Section I , Part II, to make more of the following :

a- Customs officials on duty to receive and register the import declarations :

- Import computer list of materials imported by registered enterprises (via floppy disk , CD , USB or network) when the import declaration register first batch of contracts for import of raw materials ;
- Enter computer data of customs declarations according to the computerized criteria or collate data from the enterprise with customs declaration when registering each shipment declarations .

b - Confirm completion of customs procedures on :

- For shipments are exempt from actual inspection of goods prior to certifying the completion of customs procedures , the customs officer will type the date of completion of customs procedures .
- For shipments to the actual inspection of goods , as a result of actual goods inspection , inspectors enter detailed machine actually imported goods and date of completion of customs procedures .
